

## **Shoprite Anniversary Promotion 2024 Terms and Conditions**

**Promotion Period:** The Shoprite Anniversary Promotion will commence on the 16th of September and conclude on the 27th of October 2024.

### **Eligibility:**

1. The Promotion is open to all customers of Shoprite stores in Nigeria who make purchases during the Promotion Period.
2. Participants must be at least 18 years old to be eligible.
3. Participants must possess a recognized means of ID that is recognized in Nigeria, namely:
  - Driver's License.
  - Permanent Voter's Card.
  - National Identification Number (NIN).
  - International Passport.

### **Participation and Qualification:**

1. To participate in the Promotion and qualify for the raffle draw, participants must:
  - a. Make a minimum purchase of 20,000 Naira (NGN) in a single transaction at any Shoprite store during the Promotion Period.
  - b. Include at least three (3) participating products in their purchase. Participating products will be clearly marked in-store.
2. After participants are confirmed eligible to enter the draw, the store manager records the participant's details, including name, phone number, email and takes a picture of the receipt to generate a unique code for the participant.
